### 3. INFORMATION WE COLLECT

We may collect personal data that you provide directly to us, including but not limited to:

- **Contact Information:** Name, email address, phone number, and address.

- **Source Code:** Application source code provided by clients for processing, analysis, or development purposes

### 4. LEGAL BASIS FOR PROCESSING PERSONAL DATA

- To process and analyze clients' application source code as part of our services.



- To communicate with you, including for customer service and support.
- To process transactions and manage your account.
- To send you marketing and promotional communications (only if you have opted-in for receiving marketing and promotional communications. If you are an Omnext User, you will automatically be opted-out for this type of communications).
- To comply with legal obligations and protect our rights.

## **6. SHARING YOUR INFORMATION**

We may share your personal data in the following circumstances:

- **With Service Providers:** We may share your information with third-party vendors, service providers, contractors, or agents who perform services on our behalf and are bound by confidentiality obligations.
- **For Legal Reasons:** We may disclose your personal data to comply with applicable laws, regulations, or legal requests.

- **Right to Object:** You can object to the processing of your personal data on grounds relating to your particular situation.
